ORDER

Kerala Catholic Engineering College Managements' Association [KCECMA], hereinafter referred to, for short, the Association representing 14 Member Engineering Colleges, by communication dated 07.04.2025, has submitted representation before the Fee Regulatory Committee, hereinafter referred to, for short, the Committee requesting to revise the

fee structure by applying 5% increase in the ongoing fee structure for B.Tech Courses for the current academic year, i.e. 2025-26.

- 2. Revision of fee was last done by the Committee as per the Order dated 16.04.2024. In that order it was noticed that fee from 2011-12 to 2018-19 which was at the rate of Rs. 75,000/- was not hiked during the aforementioned period despite price increase in almost all commodities and the increase in the salary of the staff members.
- 3. At the time of hearing, the representatives of the Association submitted that it would suffice for determining the revised fee structure that the principle of 5% hike in every year from 2019 onwards which was found favour with the State Government for fixing or regulating the fee structure of all Government Engineering Colleges, Aided Colleges and other Private Institutions can be appropriately applied so that regulation of fee can be done accordingly.
- 4. Committee, after due discussion, decided to accept the proposal mentioned above, in principle, and to grant cumulative enhancement of fees at the rate of 5% every year commencing from the admission of students during the academic year 2019-20; but effective only from the

admission year 2024-25. It was decided that the fee structure thus regulated by granting a notional hike at the rate of 5% every year reckoned from 2019-20 onwards in respect of the annual tuition fee of B.Tech Programmes of 2024-25 batch of students would be Rs. 1,00,500/[Rupees One Lakh Five Hundred] only.

- 5. Request of the Association is to follow the pattern of fee structure found favour with by this Committee for the academic year 2024-25 for the current academic year, i.e. 2025-26. Committee find merit in the above request of the Association and hereby decide to grant notional hike at the rate of 5% increase during this year.
- 6. Calculation statement of the fee structure as ordered above is given in the table below:

Tuition fee for the academic year 2025-26 is 1,05,525/-[Rupees One Lakh Five Thouand Five Hundred and Twenty Five Only]

7. The Principals of the member colleges (list of colleges are given in

Annexure I) are permitted to collect the tuition fee, as stated above, from the students of engineering courses per annum per student from 2025-26 batch. It is made clear that order dated 16.04.2024 will be applicable in respect of all other matters relating to fees.

- 8. Needless to say that the Engineering Colleges shall collect only the approved fee from the students of engineering courses and shall not collect, either directly or indirectly, any other amount from the students over and above the amount fixed. If any amount is charged under any other head or pretext, the institution will be liable to face penal action as per the Rulings of the Apex Court and the provisions of Act 19 of 2006.
- 9. The Principals of the Engineering Colleges are directed to collect the approved tuition fee and special fee through online payment/ cheque/DD/RTGS/IMPS only.
- 10. E-Mail copy of this order to the Government of Kerala, Higher Education Department and the President of the Association for information and necessary action.
