### ORDER

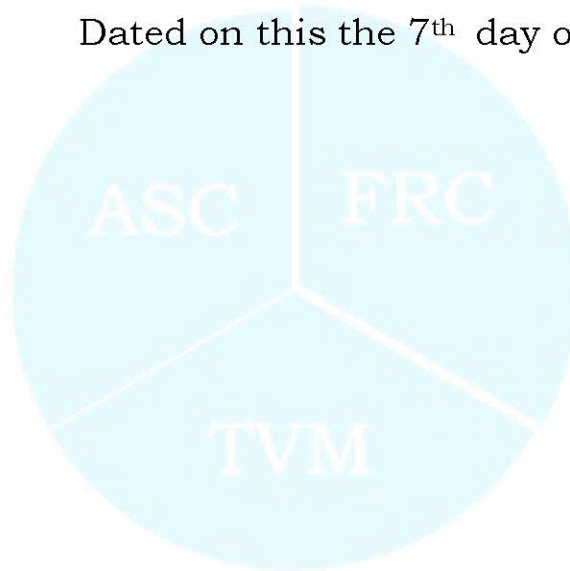
1. Kerala Catholic Engineering College Management's Association, for short KCECMA, representing 14 Engineering Colleges in Kerala, has submitted draft Prospectus and draft notification before the Admission Supervisory Committee, for short the Committee, for B.Tech NRI admission for the **14** Engineering Colleges under KCECMA during the academic year 2023-24 for approval.
2. The Committee scrutinised the draft prospectus and the same is hereby provisionally approved subject to observations and directions as stated below:-

- a. Applications invited by the College shall only be through online. No other mode of inviting application will be entertained.
  - b. College is not entitled to retain the first year tuition and other fees, if the student discontinues the course before the last date of admission prescribed by the competent authorities.
  - c. College has no right to retain the certificates and TC in the case of students leaving the college midway. Certificates shall be released to the student after getting due acknowledgement.
  - d. Admission schedule shall be clearly notified in the prospectus.
  - e. The KCECMA shall make the applicants aware of the conditions applicable for refund of tuition fee and other fees, at the time of admission itself so as to avoid future litigations.
  - f. Entire admission procedure pertaining to the inviting of application by online and giving admissions to the eligible candidates observing inter se merit shall be completed on or before the last date of closing of admission prescribed by the competent authorities.
3. Draft notification is hereby provisionally approved subject to the modifications and observations given hereunder.

- a. Approved draft notification alone shall be published in the dailies and digital media.
- b. Time schedule shown is provisionally approved. If any change is required the same shall be intimated to ASC seeking for the same.

Email this Order to the President, Kerala Catholic Engineering College Management's Association and shall inform the 14 Colleges regarding the approval of Prospectus and the conditions contained therein.
